Old Business

- 1. ST Policy Governing Request to Change Student Teaching Placement Policy Vote (Krissy Najera)
 - Krissy requested to hear feedback regarding this new policy.
 - Feedback does this policy cover when a field instructor wants to change placement and student doesn't want to change. It was also brought up that student teaching is an academic course and should we treat like other academic course situations. It was decided to focus on this policy which is for the student, and we can look at policies for clinical educators/field instructors at a later date. It was suggested that this policy apply to pre student teaching placements as well.
 - Add a #3 Conference between the field instructor, program coordinator and student.
 - Move #7 Under no circumstances should a student attempt to secure their own student teaching placement within a district to top of policy.
 - Who approves request? It was suggested it be a collaborative decision between Program Coordinator, Field Instructor and Office of Clinical Studies.
 - Who adds notes? The student will give the form to Field Instructor and Program Coordinator for them to add their notes from their meeting with student.
- 2. ST Governing Request to Student Teach Outside of the University's Supervision Vote (Krissy Najera)
 - Krissy requested to hear feedback regarding this new policy.
 - Feedback from Elementary was that would like stated that student cannot request a change to student teach at home to secure a job. Decided to leave this as a communication issue and not send to students.

- Add Mid-point virtual meeting. So, three virtual meetings.
- ACTION- It was decided to take these two policies back to faculty for review and we will put on agenda for fall meeting to vote.
- 3. UCTE mission and responsibilities update (Krissy Najera)
