Announcements

- 1. We need nominations for an undergraduate and graduate student to act as a representative for their class of students when attending UCTE meetings.
 - Basia suggested a graduate student. Debbie will reach out to her.
 - Trish will send undergraduate recommendations and Debbie will contact.

Old Business

- 1. Portrait of a UD Teacher (Diana, & Ann)
 - Ann Bullock reviewed the UDTPA concept regarding a standardized performance assessment tool and process.
 - o The context of the UDTPA is to meet the Delaware requirement of having a performance-based assessment; alignment with the UD Portrait work; can be used with content SPAs; and will provide a common assessment for CAEP.
 - The purpose of the performance assessment is to provide a multi-measure assessment where teaching candidates, during student teaching and residency, will demonstrate their pedagogical knowledge and skills, content knowledge and skills identified in the InTASC Standards, Delaware Teaching standards, and UD Portrait components while aligned with Culturally Responsive practices.
 - Overview Aligned with InTASC Standards, Delaware Standards, the UD Teacher Portrait, and Culturally Responsive Practices; Established validity and Interscorer agreement process; Completed in one clinical setting during student teaching/residency; Four tasks with timeline (gradual turn-in of different tasks); Supported by Clinical Educator; Assessed by a Field Instructor/Clinical Supervisor who has gone through the UDTPA interscorer agreement process using UDTPA rubrics
 - Next Steps: UCTE approval; committee to work on details and specifics of the UDTPA; then pilot in Spring 2024.
 - The UDTPA concept was approved.

New Business

- 1. PECB Revisions (JT Fryer)
 - Tory explained what PECB consists of and reasoning behind having such a board.
 - JT reviewed the below changes being proposed:
 - Any sanction listed on Appendix A will receive a "warning" notification letter from PECB to the student and will not be required to attend PECB meeting.
 - o Any sanction listed on Appendix B will require student to appear before PECB.
 - The candidate has at least one incident on her/his federal criminal background check that is not on record with the Office of Student Conduct.
 - The Board will consist of five members.
 - The board *appointed to a two-year term*.
 - Appendix A & B are attached.
 - Changes were approved.
